

OK VOTER GUIDE Nov 5, 2024 (early voting starts Oct 30-Nov 2)

***NOTE: This voter guide provides our recommendations in Oklahoma elections in which we are familiar. There are some races that we may miss or don't have the information needed to make a suggestion.*

For the sake of brevity we will categorize each candidate in two classes: Endorsed and Best Option.

- **Endorsed:** Those candidates who are “endorsed” meet at least 80% of [The Oklahoma Liberty Standard](#).
- **Best Option:** Those who fall into the “best option” are those who would be the best option if you feel compelled to vote. That being said, never violate your conscience!
